FOREWORD

Inaugurated in 2013, the International Centre for Innovation, Technology and Education Studies (*iCite*) of the Solvay Brussels School of Economics and Management at Université Libre de Bruxelles, aims at better understanding the drivers of innovation and welfare in our society. It gathers academics who perform multidisciplinary research and training services. Theoretical and empirical analyses aim at better understanding the economics, management and history of innovation, knowledge generation and knowledge diffusion.
